PRIVACY POLICY

This information is not sold nor provided in any way to third parties for any purpose other than for analysis that is used internally by Concept Restaurants.

EARN POINTS AND REWARDS

Earn 1 point for each \$1 spent

100 points = \$5 Concept Cash, Concept Cash rewards will expire in 60 days after the date issued and can be used at any of our participating restaurants. Rewards earned will not be converted to Concept Cash for 24 hours.

Registration Reward – Receive 200 points for signing up, the points will be added to your on line wallet that you can use 24 hours after signing up. The Expiration date will be 30 days from signing up (Email confirmation is required)

You may receive other awards and promotion offers throughout the year communicated through email.

All terms are subject to change at anytime

DECLINING EMAIL OFFERS

When you join the Local and Loyal Club, you are required to provide your email address and phone number. We communicate with you on matters related to the program, including points accrued, rewards earned, as well as promotions and offers available. If you wish not to receive email messages from us, you will forfeit the ability to earn points or redeem rewards.

ACCEPTANCE OF TERMS

By enrolling in the Local and Loyal Rewards Club, or by otherwise providing information to us, you agree to the terms of this Privacy Policy. We may change our Privacy Policy from time to time. If we change the policy and you continue to use your Local and Loyal Rewards, receive Local and Loyal communications, or otherwise use our website or other digital resources covered by this Policy, you are agreeing to such changes. You will receive one point for every \$1 you spend at participating Locations for Allowable Transactions. Allowable Transactions include purchases of food and beverage. Cover Charges, purchases of gift cards, tips, gratuities and other service charges are specifically excluded from Allowable Transactions. Discounted products and certain promotional products, as deemed appropriate from time to time, may not qualify for receipt of Points. Purchases from Event menus do not qualify for receipt of Points. Points have no monetary value and cannot be exchanged for cash. You may only receive Points for products you are paying for. You will not receive Points for products purchased and/or paid by other individuals, regardless of whether that person is a member of your party or is at your table. Max \$100 in Concept Cash may be redeemed per location per day. Rewards may change from time to time and unredeemed rewards may be forfeited at any time at Concept's discretion. Rewards have no cash value and cannot be exchanged for cash. Rewards may not be used in combination with other discounts, including coupons (irrespective of type, be it print, digital, or other), in-store promotions, or other promotional items as we feature from time to time. You must register your account, opt-in to our messages, and confirm the validity of your email address in order for Points to be converted to Rewards.
